1. Please describe in light of the responsibilities of the RESNET Board why you are the right person to be a member of the RESNET Board of Directors

I have served on the prior Quality Assurance national committee and I am currently serving on the SDC900 committee and sub-committees. My experience with this committee over a long period of time has given me a very detailed understanding of where RESNET started, has grown up and continues to gain relevance in an industry that is still just getting started. I have a very good understanding of the responsibilities of non-profits, and how RESNET fits in with other organizations such as ICC, ACCA, home inspector organizations such as Inter-nachi. 3. Please explain your knowledge and/or experience in terms of each of the primary responsibilities of the RESNET Board

1. Maintain strategic vision of the organization:

I have an opinion of the future of our business. Quality through education. Most Raters do not want to do bad work or make mistakes. I do find a lot of Raters that never were taught correctly. The honestly believe they are doing their job right. The do not or have a miss-understanding of the science. I have a vision of Less QA gotcha and more mentoring. This is just one of my pet peves but working together with a voice from those that have a strong understanding of the science along with a clear picture of the practical we will be successful.

2. Governing and oversight

Write detailed by-laws and follow the rules for everyone. This includes Quality Assurance for everyone. Keep in mind any rule and regulation is like selling widgets. You may have the best widget around but if you price it to high, do not market it correctly you may never sell a single widget. It is the responsibility of a Board to look beyond each by-law and consider the outcome. The Board must look at prospective changes, amendments, and industry changes and waves in the economy, education, national movements and determine what the possible outcome may be from each change or amendment. We can have the best organization around but if we are not careful we will not have Raters? What is our growth in the industry? What gauge are we using to gauge us against other organizations? Do we have a barometer? Are we so wrapped up in regulation are we forgetting what is important. Questions to promote thought!

3. Fiduciary responsibilities: It is not just about cash flow. Accountants always state "do not run your organization on purely cash flow" I believe this applies to every day business of any organization. Non-profits have an obligation to grow responsibly and ethically. We cannot however just gets wrapped up in the cash flow part.

4. Describe your experience in either leadership and/or serving on the board of a non-profit organization.

I am president of a Habitat for Humanity affiliate. The organization has been around 50 years. When I was asked to join the Board in 2010 the Board attendance with so low many times we did not have a quorum. I was a faithful Board member and in 2012 I was on a business trip only to return and find out I had been elected President.

For the first year, I learned, the second year I planned and the third year I have my long term plan but needed to sway my Board to agree.

We have now hired our first full time employee (executive director) fund raising is up, our books are up to date, I hired an outside accounting firm to conduct our by-annual reviews.

We are not partnering with other organizations and we have applied for a Grant to pay the full time employee annual salary.

I got some opposition from the treasurer and a few of the older members but when they realized I had a plan and it was best for the organization I had 100 percent buy in.

Leadership is being able to work in the trenches, and at the front of the table. Roll up your sleeves and work side by side with those that want to learn.

5. What would you contribute to the RESNET Board?

Thirty-five plus years of practical and education with all kinds of building products, builders, Raters, Realtors. I am not one to always voice my opinion right of the bat. I prefer to listen, consider and then provide a thoughtful response.

I have often told students it is not the person that speaks first it is the person or persons that have the correct answer.

It is still important to have those with experience. I have built it from the ground up, wired it, installed the HVAC, conducted a code inspection, Rated it, Provide QA audit on it for the Rater, reviewed it for systemic issues and I have written 50 million in repairs after it was built wrong.
