RESNET Board President John Hensley called the meeting to order at 1:31 PM Eastern.

### Roll Call

### Approve Agenda

### Approve Minutes of October 7, 2022 Executive Committee Meeting

Paradise Point, in San Diego, CA was recommended as the event site. RESNET staff had visited the site recently and found it suitable for the event.

Matt Gingrich made a motion for the RESNET Executive Committee to accept RESNET staff's recommendation to conduct the 2023 RESNET Building Performance Conference in-person in San Diego, CA in September 2023. Philip Fairey seconded. The motion passed by voice vote.

The RESNET Board of Directors will be sent an electronic ballot on this matter.

### **Approve 2023 In Person RESNET Board Meeting Locations**

Steve Baden, RESNET Executive Director, presented on RESNET staff's recommendation for the locations of the in-person board meetings in 2023. A briefing paper had been sent to the executive committee prior to the call on this matter.

Minneapolis, MN is recommended for Spring 2023. Washington, DC is recommended for Fall 2023.

Philip Fairey made a motion for the RESNET Executive Committee to accept RESNET staff's recommendation of the in-person RESNET Board meeting locations for 2023. Matt Gingrich seconded. The motion passed by voice vote.

Matt asked if the timing of the meetings is too close to each other. Philip responded that with the timing of the 2023 Building Performance Conference, it is difficult to find alternative dates.


### **New Business**
