The HERS® Index is the national standard by which a home's energy efficiency is inspected and rated and is a mainstream of the housing market

Over 4.2 MILLION homes have been rated and issued a HERS Index Score.

Builders use the RESNET HERS Index as a "Miles Per Gallon" consumer education piece on the energy performance of their buildings.

The 2015, 2018, 2021 and 2024 International Energy Conservation Codes incorporate an Energy Rating Index Score option (same as HERS Index Score).

Over 85 of the top 100 Builders are using RESNET's HERS Index and HERS Carbon Index to get their homes rated for energy and carbon.

RESNET is a Home Certification Organization for:

ENERGY STAR and Zero Energy Ready Home which are used by builders to achieve up to \$5,000 in tax credits per home under the 45L Energy Efficient New Home Tax Credit.

The RESNET HERS Index Score is product neutral.

It is a whole house energy performance analysis that allows products to compete on a level playing field and hence hasten the introduction of new products into the marketplace.
