Brian is a respected and valuable member of the SCC, and I think it is important to keep him on the committee. However, I do not feel it is right for Brian to be a voting member. While I have no insight into Brian's current relationship with NORESCO and I have utmost personal respect for him, I feel that the situation could lead to a potential bias where NORESCO weilds a stronger voting power, whether explicitly or implicitly, than other software providers. This "No" vote will trigger a re-vote. My recommendation would be for others to vote no on the re-vote, then for a new proposition to be sent which reads as follows:

"Shall the RESNET Board of Directors appoint Brian Christensen, Product Director & Chief Building Scientist at Residential Energy Management Service as a non-voting subject matter expert member of the RESNET Software Consistency Committee?"
