Addendum 46 Update – Complete rewrite of Sampling Procedures

- 1. HERS Rater shall develop a sampling plan prior to commencing sampling
- 2. RESNET must be notified by the Provider of all Sampled projects prior to conducting the initial Qualification Set.
- 3. Energy Modeling: Units shall be grouped for modeling purposes. At minimum All units shall have the same number of bedrooms and conditioned floor area within 10 percent of one another.
- 4. Sampling will begin only after the Threshold Specifications have been verified in five (5) consecutive dwelling units without any incidence of failure.
- 5. A complete set of Sampling Verifications shall be performed at a minimum rate of twenty-percent (20%) within a given set.
- 6. The minimum quantity of Sampling Verifications for each Sampled Feature within A Sampled Set shall be calculated by multiplying the number of Sampled Features by

20% and rounded the result up to the nearest whole number. (Projects containing
