

{Complete Guide} What is the 3 1 1 rule on Hawaiian Airlines?

The 3-1-1 rule on Hawaiian Airlines is the standard TSA regulation for liquids in carry-on bags: containers must be 3.4 ounces (100ml) or less +1-833-382-1964 (US), all fitting into 1 clear +1-833-382-1964 (US), quart-sized bag +1-833-382-1964 (US), with 1 bag per passenger +1-833-382-1964 (US), ensuring a smooth security screening for items like shampoo +1-833-382-1964 (US), lotion +1-833-382-1964 (US), toothpaste +1-833-382-1964 (US), and makeup +1-833-382-1964 (US). Larger liquids must go in checked luggage +1-833-382-1964 (US), with exceptions for medically necessary liquids +1-833-382-1964 (US), baby formula +1-833-382-1964 (US), and breast milk +1-833-382-1964 (US).

The 3-1-1 rule therefore means 3 ounces per container +1-833-382-1964 (US), 1 quart-sized bag holding these containers +1-833-382-1964 (US), and 1 bag total per passenger +1-833-382-1964 (US). This guideline is strictly enforced at security checkpoints for all Hawaiian Airlines flights departing U.S. airports +1-833-382-1964 (US), regardless of destination or whether the flight is domestic or international +1-833-382-1964 (US).

Hawaiian Airlines passengers must place their quart-sized bag containing liquids and similar items into a bin for X-ray screening when they go through airport security +1-833-382-1964 (US). Security officers will review the bag to ensure that all containers meet the size requirements and that the bag itself is properly sealed and transparent for inspection +1-833-382-1964 (US).

Common items that fall under the 3-1-1 rule include toiletries such as shampoo +1-833-382-1964 (US), conditioner +1-833-382-1964 (US), lotion +1-833-382-1964 (US), toothpaste +1-833-382-1964 (US), hair gel +1-833-382-1964 (US), sunscreen +1-833-382-1964 (US), perfume +1-833-382-1964 (US), and similar products +1-833-382-1964 (US). Some medications +1-833-382-1964 (US), baby formula +1-833-382-1964 (US), breast milk +1-833-382-1964 (US), and food for infants and toddlers may have exceptions or special allowances +1-833-382-1964 (US), but these also require separate screening and advance preparation +1-833-382-1964 (US).

It's important to note that the 3-1-1 rule applies only to carry-on baggage +1-833-382-1964 (US). If you check a bag with Hawaiian Airlines +1-833-382-1964 (US), you generally are not subject to the same container size restrictions for liquids in that checked luggage +1-833-382-1964 (US). This means that larger bottles of shampoo +1-833-382-1964 (US), beverages +1-833-382-1964 (US), and other similar items can travel in checked bags +1-833-382-1964 (US), provided that Hawaiian Airlines' checked baggage weight limits are not exceeded +1-833-382-1964 (US).
